SECTION 4. FIRST-AID MEASURES

First-aid Measures

Inhalation

Remove source of exposure or move to fresh air. Get medical advice or attention if you feel unwell or are concerned.

Skin Contact

Wash gently and thoroughly with lukewarm, gently flowing water and mild soap for 5 minutes. Take off contaminated clothing, shoes and leather goods (e.g. watchbands, belts). If skin irritation or a rash occurs, get medical advice or attention.

Eye Contact

Immediately rinse the contaminated eye(s) with lukewarm, gently flowing water for 15-20 minutes, while holding the eyelid(s) open. Remove contact lenses, if present and easy to do. Take care not to rinse contaminated water into the unaffected eye or onto the face. If eye irritation persists, get medical advice or attention.

Ingestion

Unsuitable Extinguishing Media

Specific Hazards Arising from the Product

Closed containers may rupture violently when heated releasing contents. Contains gas under pressure; may explode if heated. Extremely flammable aerosol. Extremely flammable liquid and vapour. Can ignite at room temperature. Releases vapour that can form explosive mixture with air. May accumulate in hazardous amounts in low-lying areas especially inside confined spaces, resulting in a fire hazard. May travel a considerable distance to a source of ignition and flash back to a leak or open container.

SECTION 6. ACCIDENTAL RELEASE MEASURES

Personal Precautions, Protective Equipment, and Emergency Procedures

Eliminate all ignition sources if safe to do so. Evacuate the area immediately. Isolate the hazard area. Keep out unnecessary and unprotected personnel. May accumulate in hazardous amounts in low-lying areas especially inside confined spaces, if ventilation is not sufficient. Remove or isolate incompatible materials as well as other hazardous materials.

Environmental Precautions
